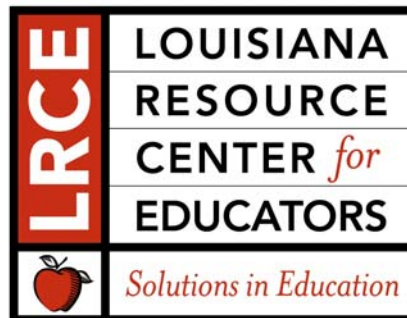

The PRAXIS Series™



The PRAXIS Series™ assessments are educational tests Louisiana uses as part of its teacher licensure and certification process. Applicants are required to pass the PRAXIS I and II Content Specialty exams by April 15, 2010 before participating in *Certification Solutions* (CS).*

To determine your appropriate Content Specialty exam, download PRAXIS Requirements at www.LRCE.org.

*Applicants with a Master's degree, ACT score of 22 or higher or SAT score of 1030 or higher are exempt from taking PRAXIS I, but must provide proof of exemption to be eligible.

Tuition



Total cost for the program is \$3,600 (excluding application and licensing fee) and the hiring school district may pay up to \$1,000 of the tuition per participant.

Qualifications



- Bachelor's degree from an accredited college or university
- Minimum 2.50 GPA
- U.S. citizenship or work permit
- Satisfactory background check as required by the hiring school system
- Passing scores on the PRAXIS I and II Content Specialty exams by April 15, 2010

Application Timeline



January 4, 2010-March 19, 2010

Submit completed packet to CS.

Applications will not be accepted after March 19, 2010.

Applications will be pre-screened prior to applicants being notified about whether or not they have been selected for an interview.

Acceptance (and rejection) letters will be emailed within three weeks of the personal interview. Acceptance will be provisional until passing PRAXIS I and II Content Specialty scores have been submitted (the deadline to submit passing scores is April 15, 2010).

CS Overview



STEP 1

Summer Institute, May 24-July 9, 2010

7 week course, M-F approx. 8:30 a.m. -4:30 p.m.

Curriculum:

- Educational theory and methodology seminars
- Field experience at area summer schools (field experience times may vary)
- Assessment
- Special Education and Reading in the Content Area workshops
- School Law seminar

STEP 2

Teaching Full-Time (on your Practitioner's License)

Support Services:

- Learning Team seminars (twice monthly, 5:30 p.m.-8:30 p.m.)
Content specific training on lesson plans, discipline, professional development and best practices
- Practitioner Advisors
Mentors providing onsite guidance and support

STEP 3

Level 1 Certification

Requirements:

- Completion of one full school year (180 days) of teaching on a Practitioner's License
- Passing scores on PRAXIS Principles of Learning and Teaching or Special Education exams
- Positive evaluations from principal, school district, CS Learning Team leader, Practitioner Advisor, and CS Director/Staff
- Regular attendance and participation at CS Learning Team seminars
- Full payment of the \$3,600 tuition

Once accepted into the program, Practitioner Teachers have a maximum of 36 months to meet the certification requirements. Certification can be obtained in a minimum of 15 months.
